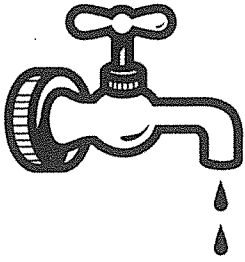

WATER SYSTEM INFORMATION:

This report shows our water quality and what it means. If you have any questions about this report or concerning your water utility, please contact the Customer Service Department at (724) 929-3370.

We want you to be informed about your water supply. If you want to learn more, please attend any of our regularly scheduled meetings. They are held the last Tuesday of the month at 7:00 PM at the Washington Township Community Building, located at 1392 Fayette Avenue, Belle Vernon, Pa.

SOURCE(S) OF WATER:

Our water source is the Monongahela River in Fayette City, Pa. We also purchase a small portion of water from the Municipal Authority of Westmoreland County (PSWID 5260036). We are proud that your drinking water meets or exceeds all Federal and State requirements.

A *Source Water Assessment* of our source was completed by the PA Department of Environmental Protection (Pa. DEP). The Assessment has found that our source is potentially most susceptible to Transportation / Road Deicing, Wildcat Sewer Outfalls, Utility Substations, Marinas, Barges, Shipping, Urban Areas, Power Plants, Strip Mines and Wastewater Treatment. Overall, our source has moderate to high risk of significant contamination. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. MONITORING YOUR WATER:

We routinely monitor for contaminants in your drinking water according to federal and state laws. The following tables show the results of our monitoring for the period of January 1 to December 31, 2016. The State allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data is from prior years in accordance with the Safe Drinking Water Act. The date has been noted on the sampling results table.

DEFINITIONS:

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Minimum Residual Disinfectant Level (MinRDL) - The minimum level of residual disinfectant required at the entry point to the distribution system.

Treatment Technique (TT) - A required process intended to reduce the level of a contaminant in drinking water.

Running Annual Average (RAA) – The average, computed quarterly, of quarterly arithmetic averages of all analytical results for samples taken during the most recent 4 calendar quarter.

ppb = parts per billion, or micrograms per liter (µg/L)

ppm = parts per million, or milligrams per liter (mg/L)

Nephelometric Turbidity Units (NTU)- A measure of water clarity.

Information about Lead

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Municipal Authority of Washington Township is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. OTHER VIOLATIONS:

1) Our lab failed to submit a report to the DEP for a sample that was timely done by the Authority. Upon discovery, the lab submitted the report.

2) We took our 2Q16 TOC sample a few days early, which resulted in 2 samples for the 1Q16 and no results submitted for the 2Q16. (Please see the attached notices.)

EDUCATIONAL INFORMATION:

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water run-off, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA and DEP prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA and DEP regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Reporting Requirements Not Met for Municipal Authority of Washington Township

We violated a drinking water reporting requirement.

- We failed to submit a laboratory monitoring report after properly conducting monitoring in a timely manner.
- We failed to submit a completed assessment form after properly conducting the assessment in a timely manner.
- Our seasonal noncommunity water system (NCWS) failed to submit certification of completion of a state-approved start-up procedure. Our written records show start-up was performed and sampling showed no contamination.

What should I do?

There is nothing you need to do at this time. You may continue to drink the water. If a situation should arise where the water is no longer safe to drink, you will be notified within 24 hours.

What happened? What was done?

Our lab failed to submit a report to the DEP for a sample that was timely done by the Authority. Upon discovery, the lab submitted the report.

Monitoring Requirements Not Met for Municipal Authority of Washington Township

Our water system violated several drinking water standards over the past year. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 2016 we incurred a monitoring violation for missing the second quarter TOC (Total Organic Carbon) and therefore cannot be sure of the quality of our drinking water during that time.

What should I do?

There is nothing you need to do at this time. **Your water is safe to drink.**

We did not properly test for TOC for the required quarterly sampling. We took 2 samples in the 1Q16 (Jan – March) and took no sample in the 2Q16 (April – June).

You may continue to drink the water. If a situation should arise where the water is no longer safe to drink, you will be notified within 24 hours.

What happened? What was done?

We took our 2Q16 TOC sample a few days early in March, which resulted in 2 samples for the 1Q16 (Jan – March) and no sample for the 2Q16 (April - June) so it did not count for the 2Q16 but it was done. We took the required 3rd and 4th quarter samples.
